## Executive Director Report

What a year it's been.

At the onset of 2020, there were initially no indications that we would very soon be facing significant challenges in the delivery of our programs. At the beginning of the year we were seeing strong government support for abstinence based treatment centres and new funding was being announced that would improve the ease of access to all Albertans. The last thing on our minds at that time was a global pandemic and all of the challenges that come with it.

With adversity however, comes opportunity.

Staff and clients - At the beginning of the pandemic, we saw incredible resilience come to the surface with our staff and clients alike. Even before we received specific direction from Alberta Health, we activated our Pandemic Response Plan. Staff that could work remotely were given the tools to enable them to do so. Additional counselling staff were brought on to help with the extra work load of COVID-19 symptoms screening and disinfection requirements. Clients and staff who showed possible symptoms were isolated and tested. Through the diligence of our staff and policies, we are happy to report that we have not had a single case of COVID-19 at any of our facilities to date. Though the number of clients we can accommodate has been reduced, we have still been able to maintain a waitlist of less than 2 weeks throughout the majority of the pandemic, with some clients even able to start with no wait period at all. Indeed many businesses and services were forced to close during the more tense parts of this pandemic, but Recovery Acres has remained open at all times.

- Collaboration between agencies The pandemic has brought all of the treatment agencies closer than they have ever been before. The AASP (Alberta Addiction Service Providers), of which RACS has been a member, became a registered Society. Through the AASP, we have been able to very closely work and collaborate with dozens of other similar agencies around Alberta. One such agency is Oxford House. For the past decade, RACS has been collaborating with Oxford House. Through their pre-treatment housing model, we have been able to ensure that anyone waiting for access to treatment has a safe and stable living environment. At RACS we do not view ourselves as being in competition with other similar agencies, rather that we are partners in the effort to help those who live with substance use disorders achieve long term recovery and restore individual, family and communities to wellness.
- Government support This past year has also seen the Government of Alberta making major changes to access of residential treatment services for all Albertans. Funding barriers have been greatly reduced, and as of October 1, 2020, any resident of Alberta has not needed to pay for residential treatment services at any funded and licensed agency. New funding pathways for agencies were announced, and we were invited to respond to an RFEOIQ (Request For Expression Of Interest Qualification) that will see funding for both residential treatment as well as residential recovery beds. We are expecting the results of our application in the coming weeks, and will continue to work with all levels of government to reach our vision that long-term recovery is available for all who live with substance use disorders and co-occurring mental health concerns.

Forging ahead – One thing the past year has shown us is the strength of the team we have in place at RACS. With the combined enthusiasm and talent of our current staff, we are excited about our prospects in the future. We have enlisted the folks at Impact8 to help facilitate strategic planning sessions that will guide our journey in the coming months and years. RACS has been providing services for nearly 50 years, and we are keen to adapt and improve in order to remain the place of choice for many years to come. Pandemic restrictions are in the process of loosening for the general public here in Alberta. Vaccinations are being made available much sooner than first anticipated, and through the cooperation of the public we are at last nearing the light at the end of the tunnel we've been in. At RACS we are required to adhere to a special health order for addiction treatment centres issued by the Chief Medical Officer of Health in Alberta, Dr. Deena Hinshaw. When a revised Health Order is issued, we will likely see the return of activities and gatherings here at our main facility. We're eager to see this happen, and we're already well under way in the planning of our next golf tournament, with many other activities also being discussed.
