The winner will be required to answer a skill testing question before being declared the winner. D. The Prize

The winner of the Grand Prize will receive an all expense paid entry to the 2022 Recovery Acres Charity Class on August 15, 2022 at Elbow Springs Golf and Country Club – includes: Green Fees, Cart, Lunch, Dinner, Tee Gifts and Hole-in-One chances for cars, trips, a \$Million and much, much more.

F. TRANSFERABILITY

9. The Grand Prize is totally transferable but cannot be exchanged for cash.
